RE: UE 250 - PGE October 1, 2012, MONET Update

Enclosed is PGE's October 1, 2012, MONET update for Docket No. UE 250. This update includes 2013 contracts, and 2013 electric and gas forward curves as of September 6, 2012, as well as the adjustments discussed in the Stipulation in this docket filed with the Commission on September 6, 2012. Also included in this power cost update filing is an updated 2013 load forecast. PGE's Net Variable Power Cost (NVPC) forecast for 2013 totals approximately \$667.24 million, a reduction of approximately \$5.64 million from the July 16, 2012, update filing. This decrease is primarily due to the adjustments agreed to in the Stipulation. PGE is aware of one contract with a qualifying facility currently in the process of being finalized that is expected to increase the 2013 NVPC forecast when it is modeled in Monet for the November 7, 2012, update filing.

PGE will adjust its November 2012 direct access election window to remain open through 5:00 PM Monday, November 26th, to accommodate the Thanksgiving holiday. We have informed Energy Service Suppliers that our offices will be closed on Friday, November 23rd, and therefore we will not be able to process election requests or address questions on that date. PGE will also communicate this change in the duration of the election window to customers.
