NOTICE OF INTENT TO REQUEST AN ISSUE FUND GRANT OF THE CITIZENS' UTILITY BOARD OF OREGON

The Citizens' Utility Board of Oregon (CUB) files this Notice of Intent to Request an Issue Fund Grant in UE 262, pursuant to OAR 860-001-0120 and the Second Amended and Restated Intervenor Funding Agreement (IFA), approved by the Oregon Public Utility Commission (Commission) in Order No. 12-452 (November 20, 2012).

- Portland General Electric (PGE) has filed its Request for General Rate
 Revision. The Commission will examine this filing in Docket No. UE 262.

- 7. CUB will file a proposed budget with respect to the Issue Fund Grant, as provided in Article 6.3 of the IFA.
