RE: UE 266 - PGE November 15, 2013 Final MONET Update

Enclosed is PGE's November 15, 2013 MONET update for Docket No. UE 266. This update includes 2014 electric and natural gas forward prices based on a five-day average of the November 1, 2013 through November 7, 2013 forward curves. PGE's final Net Variable Power Cost (NVPC) forecast for 2014 totals approximately \$621.7 million, a reduction of approximately \$1.29 million from the November 5, 2013 update filing.

In Step 142 of this update, PGE removed a Peak Capacity Purchase previously included in the July MONET update step log. Removing this contract lowers NVPC by approximately \$219,000.
