7	Net Variable Power Costs and Annual Power Cost Update.
8	On June 11, 2013, Portland General Electric Co. (PGE) notified the administrative law
9	judge (ALJ) that the parties to the docket had reached a settlement in principle and asked the
10	ALJ to suspend the procedural schedule to allow parties to reduce the agreement to writing. On
11	June 12, 2013, the ALJ issued a ruling temporarily suspending the procedural schedule and
12	directing the parties to either file a stipulation or a status report by June 25, 2013. In accordance
13	with that ruling, staff of the Public Utility Commission of Oregon (staff) files this status report.
14	PGE has drafted a written agreement and supporting testimony and parties are currently
15	circulating edits to the proposed drafts. The stipulation is taking longer to finalize than the
16	originally anticipated two weeks because of parties' workload and schedules. The parties
17	anticipate that the stipulation and supporting testimony will be filed soon and in any event, no
18	later than July 5, 2013.
