I, KEVIN HIGGINS, being first duly sworn on oath, depose and say:

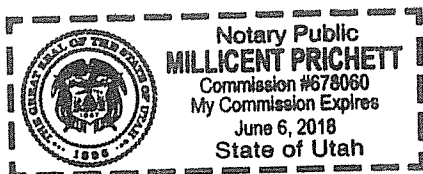
1. My full name is Kevin C. Higgins. I am Principal with Energy Strategies, LLC and am testifying on behalf of The Kroger Co.


