

I, Robert (Bob) Jenks, being duly sworn on oath, depose and say:

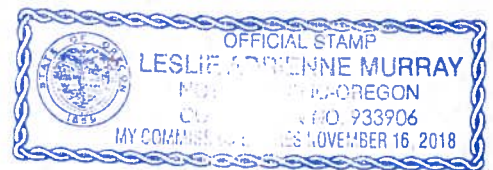


