Pursuant to Article 6.7 of the Fourth Amended and Restated Intervenor Funding Agreement ("IFA"), approved by the Oregon Public Utility Commission ("Commission") by Order No. 18-017 (January 17, 2018), the Alliance of Western Energy Consumers ("AWEC") files this Request for Amendment of Proposed Budget in Docket No. UE 358 (the "Proceeding"), seeking an increase of \$6,507.55 to its approved Issue Fund Grant in this Proceeding, for a new grant in the amount \$28,507.55.

On April 9, 2019, AWEC filed a Request for Issue Fund Grant and Proposed Budget in this Proceeding, showing eligible expenses in the amount of \$27,500 and requesting an Issue Fund Grant in the amount of \$22,000. On April 18, 2019, the Commission approved AWEC's proposed budget by Order No. 19-138. AWEC is now requesting an amendment to its approved budget, showing eligible expenses of \$35,634.44 and seeking an Issue Fund Grant in the amount of \$28,507.55. Since AWEC has unused amounts in its approved Issue Fund Grant in Docket No. UE 359, AWEC requests that \$6,507.55 be reallocated from its UE 359 Issue Fund Grant for use in this Proceeding.

PAGE 1 – AWEC REQUEST FOR AMENDMENT OF PROPOSED BUDGET

Article 6.7 of the IFA states:

Amendment of Proposed Budget: At any time during the proceeding, an

intervenor who received Commission approval for an Issue Fund Grant may file to amend its

budget and request additional funding due to unforeseen changes in the scope or complexity of

issues, positions taken by other parties, changes in the schedule of the case, or other good cause.

An intervenor with approved proposed budgets in multiple dockets may request to reallocate

approved amounts between dockets by filing a request in both dockets.

AWEC seeks approval to amend its initially authorized budget in this proceeding,

as the proceeding as been more complex and time-consuming than initially anticipated.

Pursuant to Article 6.7 of the IFA, AWEC is concurrently filing a Request for

Final Payment and Reallocation of Issue Fund Grant in Docket No. UE 359.

Therefore, AWEC respectfully requests that the Commission issue an order

granting AWEC's Request for Amendment of its Proposed Budget in this Proceeding.
