#### RE: UE 377 – November 16, 2020 Final MONET Update

Enclosed is PGE's November 16, 2020 final MONET update for Docket No. UE 377. This update includes 2021 electric and natural gas forward prices based on a five-day average of the November 2, 2020 through November 6, 2020 forward curves. PGE's final Net Variable Power Cost (NVPC) forecast for 2021 totals approximately \$457.9 million, a reduction of approximately \$1.2 million from the November 6, 2020 update filing. The decrease is due to the updates to electric and natural gas forward prices and Qualifying Facilities contracts.
