1. INTRODUCTION

Pursuant to the Administrative Law Judge ("ALJ") April 4, 2022 Procedural Conference Memorandum in this matter, Small Business Utility Advocates ("SBUA") submits this Proposed Budget of SBUA ("Proposed Budget") in the event the Commission grants the Petition for Case Certification of Small Business Utility Advocates filed April 13, 2022. This Proposed Budget is required pursuant to Section 6.3 Fourth Amended and Restated Intervenor Funding Agreement, approved by Order 18-017 ("Agreement")(Implementing ORS 757.072 and OAR 860-001-0120 and 860-001-0130). SBUA submits this Proposed Budget to assist SBUA in representing small commercial customers of PacifiCorp dba Pacific Power ("Company") in this general rate case.

2. REQUIREMENTS FOR AN ISSUE FUND GRANT PROPOSED BUDGET

The Proposed Budget must include: (a) a statement of work to be performed by the applicant for which the applicant is seeking an Issue Fund Grant; (b) a description of the areas to be investigated by the intervenor; (c) a description of the particular customer class or classes that will benefit from the intervenor's participation; (d) identification of the specific account or accounts from which the intervenor is seeking an Issue Fund Grant and an estimate of the amount of available funds in that account; (e) a budget showing estimated attorney fees, which may include the cost for appropriate support staff and operational support; (f) a budget showing estimated consultant fees and expert witness fees, which may include the cost for appropriate support staff and operational support; and (g) a representation that the intervenor will use matching funds in the form of either in-house resources or outside funding to account for or pay at least

20% of the Eligible Expenses for the work to be performed for which the intervenor is seeking an Issue Fund Grant.¹

(a) A statement of work to be performed by the applicant for which the applicant is seeking an Issue Fund Grant.

SBUA represents small business including small commercial customers in this docket.

SBUA will participate in events identified in the ALJ April 4, 2022 Procedural Conference

Memorandum including settlement conferences and other meetings, providing testimony, legal briefings, data requests and responses, and hearing. SBUA will be assisted by expert, William A. Steele, who served SBUA in the Company's directly previous rate case, UE 374.

(b) A description of the areas to be investigated by the applicant.

To ensure fair and reasonable rates for small businesses, SBUA would review return on equity and capital structure, justification for the base change of 10.3% with a net change of 9.5% to Schedule 23 rates. SBUA would also review cost allocation methods used by the Company that affect small business, and rate spread and rate design, particularly as impacts small commercial customers. In addition, SBUA would review the deferred accounting regarding costs for Transportation Electrification program (docket UM 1964) recently consolidated in this general rate case pursuant to the April 11, 2022 ALJ Ruling "Disposition: Motion to Consolidate Granted in Part; Denied in Part". SBUA reserves the right to review other issues raised by the Company or by other parties.

(c) A description of the particular customer class or classes that will benefit from the intervenor's participation.

The particular customer classes that would benefit from SBUA's participating in the proceeding is the Schedule 23 General Service — Small Nonresidential.²

(d) Identification of the specific account or accounts from which the intervenor is seeking an Issue Fund Grant and an estimate of the amount of available funds in each account.

The accounts from which SBUA seeks Issue Fund grant is PacifiCorp dba Pacific Power: at the time of preparing this Proposed Budget the amount remaining in the Issue Fund Grant was not available.³

(e), (f), and (g) require a budget showing estimated attorney fees, which may include the cost for appropriate support staff and operational support, a budget showing estimated consultant fees and expert witness fees, which may include the cost for appropriate support staff and operational support, and a representation that the intervenor will use matching funds in the form of either in-house resources or outside funding to account for or pay at least 20% of the Eligible Expenses for the work to be performed for which the intervenor is seeking an Issue Fund Grant.

In response to these requirements "e", "f", and "g", SBUA submits the attached UE 399

Proposed Budget of SBUA Exhibit A as a Budget for the Issue Fund Grant requested.
