STATUS UPDATE

In accordance with the Administrative Law Judge’s Ruling issued November 10, 2022, Portland General Electric Company (PGE) hereby submits this Status Update and submits a preliminary draft of the Regulated Results of Operation Report (ROO) for the 2022 calendar year.

Since the most recent status update, filed February 16, 2023, General Protective Order No. 23-066 was issued on March 2, 2023. PGE, Staff of the Public Utility Commission of Oregon, Oregon Citizens' Utility Board, and Alliance of Western Energy Consumers (jointly, “the Parties”) have engaged in productive settlement discussions. The Parties plan to meet again during the week of March 6th to continue settlement discussions. PGE is providing a preliminary ROO for the 2022 calendar year as CONFIDENTIAL Attachment A.
