RE: UE 416 PGE 2024 Annual Power Cost Update – PGE's November 15, 2023 Final MONET Update

Enclosed is PGE's November 15, 2023, final MONET update for Docket No. UE 416. This update includes 2024 electric and natural gas forward prices based on a five-day average of the November 1, 2023 through November 3, 2023, and November 6 and 7, 2023 forward curves. PGE's final Net Variable Power Cost (NVPC) forecast for 2024 totals approximately \$977.7 million, a decrease of approximately \$2.5 million from the November 7, 2023 MONET update.

The decrease is due to updates to: 1) electric and natural gas forward prices; and 2) the price for the energy generation at the Priest Rapids and Wanapum hydro facilities, as provided in the power contract between PGE and Grant County.
