This filing is made in compliance with Order 22-389 adopting the uncontested comprehensive stipulation in UE 400, the 2023 Transition Adjustment Mechanism (TAM). In that order, the Commission clarified the expectations for PacifiCorp to provide information for review of certain CSAs in a TAM proceeding. This information is being provided more than 45 days before the first round of Staff and intervenor testimony in the 2025 TAM.
