The Citizens' Utility Board of Oregon (CUB) files this Notice of Intent to Request an Issue Fund Grant in UG 246, pursuant to OAR 860-001-0120 and the Second Amended and Restated Intervenor Funding Agreement (IFA), approved by the Oregon Public Utility Commission (Commission) in Order No. 12-452 (November 20, 2012).

- Avista Utilities (Avista) has filed its Request for a General Rate Revision. The Commission will examine this filing in Docket No. UG 246.

- CUB will file a proposed budget with respect to the Issue Fund Grant, as provided in Article 6.3 of the IFA.
