Notice

On August 15, Avista filed a request with the Public Utility Commission of Oregon (PUC) to increase natural gas rates by an overall 9.8 percent, or \$9.5 million. If the request is approved, a residential customer using an average of 48 therms a month would see a \$6.17 increase, or 10.6 percent, for a revised monthly bill of \$64.17.

We asked for this adjustment to recover capital investments to expand and replace the facilities we use every day to serve our customers. This includes, among other things, increased investment to replace certain natural gas service pipe and to update the technology that is the backbone of our customer information system.

Avista will also make its annual Purchased Gas Adjustment (PGA) filing by August 30. PGAs are filed each year to balance the actual cost of wholesale natural gas purchased by Avista to serve customers with the amount included in rates. The PGA filing is separate from the general rate request and has no impact on company earnings.
