Notice

On Sept. 2, 2014, Avista filed a request with the Public Utility Commission of Oregon (PUC) to increase natural gas base rates by an overall 9.3 percent, or \$9.1 million. If the request is approved, a residential customer using an average of 47 therms a month would see a \$5.78 increase, or 10.3 percent, for a revised monthly bill of \$61.75.

We asked for this adjustment to recover capital investments to expand and replace the facilities we use every day to serve our customers. This includes, among other things, increased investment to update the technology that is the backbone of our customer information system and the replacement of natural gas pipe.

As required by the PUC, Avista filed its annual Purchased Gas Cost Adjustment (PGA) in July 2014. PGAs are filed each year to balance the actual cost of wholesale natural gas purchased by Avista to serve customers with the amount included in rates. The PGA filing is separate from the general rate request and does not increase or decrease the company's earnings.
