10	its October 26, 2018 order. (Order No. 18-419) Paragraph 18 of the Second Partial Stipulation		
11	provides that if the Commission rejects all or any material portion of this Stipulation, any of the		
12	stipulating parties are entitled to withdraw from the stipulation and must file a notice within five		
13	days of the Commission order rejecting the stipulation to do so. ¹		
14	Staff files this notice past the five-day period. Staff notified the stipulating parties on		
15	November 7, 2018 of its intent to withdraw. Although this notice is filed outside the five day		
16	period, the schedule for the additional process ordered by the Commission has not been		
17	established and Staff believes that no party is harmed by this delay. Further, paragraph 20 of the		
18	Second Partial Stipulation provides that the stipulation is not enforceable by any stipulating party		
19	unless and until adopted by the Commission. ² Accordingly, the provision regarding withdrawal		
20	from the stipulation is no longer enforceable.
