NOTICE OF INTENT TO REQUEST AN ISSUE FUND GRANT OF THE CITIZENS' UTILITY BOARD OF OREGON

The Citizens Utility Board of Oregon (CUB) files this Notice of Intent to Request an

Issue Fund Grant in UM 1050, pursuant to OAR 860-012-0100 and the First Amended and

Restated Intervenor Funding Agreement (IFA), approved by the Oregon Public Utility

Commission (Commission) in Order No. 07-576 (December 20, 2007).

- 1. PacifiCorp filed a Request to Initiate an Investigation of Multi-Jurisdictional Issues and Approve an Inter-Jurisdictional Cost Allocation Protocol. The Commission examines this application in Docket No. UM 1050.
- 2. UM 1050 is an Eligible Proceeding under the IFA. The IFA defines an Eligible Proceeding as "any Commission proceeding that directly affects one or more of the Participating public Utilities." IFA, Section 1(c).

- CUB will file a proposed budget with respect to the Issue Fund Grant, as provided in Section 6.3 of the IFA.
