Re: Docket UM 1083, RCC Minnesota, Inc. Errata to Order No. 04-355

Staff has reviewed RCC Minnesota's (RCC's) December 6, 2005, request for issuance of an errata order to Order No. 04-355.

Staff generally concurs with the requested corrections and supports the issuance of an errata order to correct the Appendix B wire center listings that were included in Order No. 04-355, RCC's original designation order. However, Staff has identified one error in Exhibit 1 of RCC's request. Exhibit 1 of RCC's request, which represents a corrected list of wire centers comprising RCC Minnesota's designated service area for federal universal service support purposes, shows CenturyTel of Eastern Oregon's study area code (SAC) as 532360. The correct SAC for CenturyTel of Eastern Oregon is 532361.

In addition, Appendix B in Order No. 04-355 contained an incorrect spelling of the Stanfield wire center of Qwest Corporation. The Order listed this wire center as "Standfield." RCC's Exhibit 1 contains the correct spelling, but RCC did not note this correction in Exhibit 4 of its request where it explains requested revisions to the Order No. 04-355 Appendix B list of wire centers.

Neither of these changes have a material impact on the validity of RCC's request. Staff has contacted RCC regarding these changes, and RCC agrees with the changes proposed.

Attached is a revised version of RCC's Exhibit 1 that includes the correct CenturyTel SAC. This list represents a corrected version of the Appendix B list in Order No. 04-355.
