In a conference call on July 7, 2004, you, Jay Dudley, and I discussed the process by which you would resolve the issues identified in the July 2, 2004 Stipulation Regarding Deposition executed by the Industrial Customers of Northwest Utilities ("ICNU") and Portland General Electric Company ("PGE" or the "Company"). Today, I received an email from Ben Walters, Deputy City Attorney for the City of Portland, who indicated that you had indicated to him that ICNU had withdrawn its objections to PGE's confidential designation of many of the documents provided in response to ICNU DR 5.1. I want to clarify that ICNU has not withdrawn its objections to the confidential designation of the documents provided to you by PGE.

On July 2, 2004, ICNU sent you a letter in which ICNU stated that it objected to the confidential designation of all documents provided in response to DR 5.1 with the exception of a limited number of documents. As stated in the letter, the documents to which ICNU does not object to the confidential designation are marked with bates numbers: 1) 202980 – 203010; 2) 203013 – 203038; and 3) 203039 – 203066.

On July 7, 2004, PGE informed ICNU that the Company had removed the confidential designation from certain documents that were designated confidential in PGE's

initial response to ICNU DR 5.1. According to the list provided to ICNU by PGE, those documents are marked with bates numbers:

PGE 202932-42	PGE 203207-18

PGE 203203	PGE 203282-83

As a result of PGE's decision to remove the confidential designation from these documents, it is unnecessary for you to review them to determine whether the confidential designation applies. However, ICNU maintains its objection to the confidential designation of all the documents identified in the July 2, 2004 letter to you. Accordingly, ICNU requests that you determine whether all documents submitted to you by PGE warrant the confidential designation other than: 1) those documents for which PGE has removed the confidential designation; and 2) those specific documents to which ICNU does not object (bates numbers: 202980 - 203010; 203013 - 203038; and 203039 - 203066).
