<u>Section 7.3(b)</u> – ICNU was a full and active participant in this Docket. ICNU conducted extensive discovery, submitted direct testimony, filed opening comments, participated in settlement workshops and discussions, drafted provisions for a stipulation to resolve all issues in this Docket, and submitted testimony and a brief in support of the stipulation. The expenses included in Confidential Exhibit A are reasonable and directly attributable to ICNU's participation in UM 1209.
