

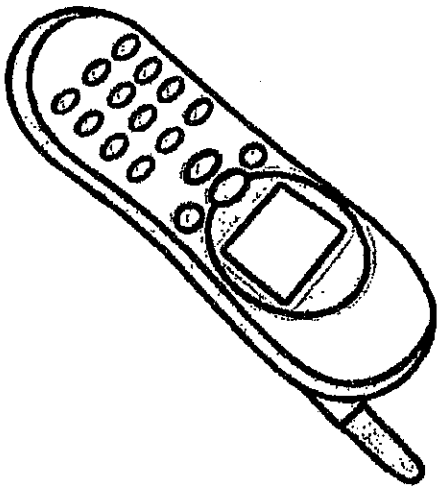

EXHIBIT I

This Exhibit I is intended to supplement the Substitute Application filed on September 7, 2006. Beginning at Page 8 of the Substitute Application, there is a description of the service plans that are available to customers. At the time the Substitute Application was submitted, those were the only two plans that were offered. Since that time, a third plan has been added. The third plan is known as the Mini Personal Plan.

Attached is a description of the plan. The plan allows 200 local home minutes and 40 local travel minutes with unlimited nights and weekends in the home area for \$22.50. The plan includes long distance, voice mail, caller ID and unlimited incoming text messages. There are overage charges for exceeding the allotted minutes. There are additional add-on features in terms of additional minutes that can be purchased and other services that are described on the attachment.
