This letter is to update you regarding the status of Docket No. UM 1261, which concerns Idaho Power Company's application to defer excess net variable power costs incurred from May 1, 2006 to April 30, 2007 ("the deferral period"). The parties to this docket, which include Idaho Power, staff, and the Citizens' Utility Board (CUB), met on Wednesday, April 25, 2007, for a settlement conference. The parties have reached a settlement resolving the issues presented by Idaho Power's request to defer excess net variable power costs incurred during the deferral period. The parties will submit the stipulation and supporting testimony or brief as soon as these documents are completed.
