Pursuant to Section 7.3 of the First Amended and Restated Intervenor Funding Agreement ("IFA") approved by the Oregon Public Utility Commission ("Commission") by Order No. 07-564 (December 19, 2007), the Industrial Customers of Northwest Utilities ("ICNU") hereby requests final payment of ICNU's Issue Fund Grant in Docket No. UM 1355 in the amount of \$23,040. ICNU requests that the payment amount be split equally between Portland General Electric ("PGE") and PacifiCorp.

On October 17, 2008, ICNU filed a Notice of Intent to Request an Issue Fund Grant in Docket No. UM 1355. On December 5, 2008, ICNU filed a proposed budget in the amount of \$23,040 in Docket No. UM 1355. The Commission approved an Issue Fund Grant for ICNU (to be split equally between PGE and PacifiCorp) in the amount of \$23,040 on December 16, 2008. Re OPUC, OPUC Docket No. UM 1355, Order No. 08-588 (December 16, 2008). As a result, ICNU has an approved Issue Fund grant of \$23,040 in this proceeding. Pursuant to Order No. 08-588, ICNU is requesting final payment in this docket from the issue funds of PacifiCorp and PGE, resulting in a final payment of \$11,520 due from each utility.

ICNU hereby requests that the Commission authorize final payment of the Issue Fund Grant in the amount of \$23,040. ICNU's expenses are shown in Confidential Attachment A.

PAGE 1 – REOUEST FOR FINAL PAYMENT OF ISSUE FUND GRANT OF ICNU

This Request for Payment satisfies the requirements of the IFA as follows:

<u>Section 7.3(a)</u> – The itemized expenses, payees, and hourly rates are attached as Confidential Exhibit A.

<u>Section 7.3(b)</u> – ICNU has been a full and active participant in this Docket. ICNU conducted discovery, participated in workshops, filed testimony, entered into a settlement stipulation and intends to participate in any hearings and file legal briefs. The expenses included in Confidential Exhibit A are reasonable and directly attributable to ICNU's participation in Docket No. UM 1355.

<u>Section 7.3(c)</u> – The Commission approved ICNU's proposed budget on December 16, 2008. In addition, ICNU used its own funds to pay for at least 20% of the Eligible Expenses as required by Section 6.5 of the IFA.

<u>Section 7.4</u> – All of the expenses included in Exhibit A are Eligible Expenses as defined in Section 7.4 of the IFA because they relate to services provided or expenses incurred by ICNU's outside legal counsel and expert witnesses. Relevant non-privileged documents substantiating the Eligible Expenses in Confidential Exhibit A are available for Commission audit, if requested, pursuant to Section 7.10 of the IFA.

The IFA provides that the granting of "an Issue Fund Grant shall constitute a binding obligation on the Commission to order reimbursement of Eligible Expenses." IFA § 6.5. Likewise, the intervenor funding rules adopted by the Commission provide that "the terms of an [intervenor funding] agreement will be binding on all organizations seeking a grant under that agreement and will be followed by the Commission in administering the agreement."

OAR § 860-012-0100(2). ICNU has satisfied the terms of the IFA and respectfully requests that the Commission approve final payment of ICNU's Issue Fund Grant in the amount of \$23,040 (\$11,520 from PGE and \$11,520 from PacifiCorp) within 30 days of receiving this Request for Final Payment as provided in Section 7.6 of the IFA. This Request for Payment constitutes a Final Request for Payment in this docket.
