The **Oregon Telecommunications Relay Service** is a telephone service accessible by dialing **711** that allows individuals with hearing or speech impairments to place and receive calls through a 3rd party operator using a TTY.

Another available service of the Telecommunications Relay Service is known as **CapTel** or captioned telephone. **CapTel** uses voice recognition technology that transcribes everything the other party says into written text. It allows deaf and hard of hearing people to speak and read captions that appear on the phone almost simultaneously. "Hidden" operators listen and restate the conversation of the hearing party into the voice recognition software. After receiving the CapTel, contact CapTel customer service to notify them of your long distance carrier at 1.888.269.7477.
