Pursuant to your request, we are providing this status report in docket UM 1514. We regret that a Stipulation and supporting testimony are not yet ready to be filed. The parties have made significant progress toward a Stipulation and anticipate being able to file it within one week.

You also requested that this status report address specific deadlines or timing concerns regarding the order date. The associated tariff filing, Advice 10-29, is currently on the Commission's public meeting calendar for May 3. PGE will shortly file to extend the effective date of that tariff and request that this matter be removed from the May 3 calendar. In order to have the Automated Demand Response program in place and functioning in time for the winter season, we need to have a Commission Order by June 1. We do not anticipate any opposition to the Stipulation, and hope that this is sufficient time for the Commission to address the matter.

If you need any additional information please let me know. Once again, we regret the delays in this docket, but are working toward a resolution.
