Pursuant to Section 5.1 of the Multi-State Process ("MSP") Second Amended and Restated Intervenor Funding Agreement ("IFA") approved by the Public Utility Commission of Oregon ("Commission") via Order No. 17-028, the Industrial Customers of Northwest Utilities ("ICNU") files this Proposed Budget seeking an MSP Issue Fund Grant in the amount of \$65,000 for 2017. ICNU proposes that this grant be funded from the PacifiCorp MSP Issue Fund Account. The following information is provided in accordance with Section 5.1 of the IFA:

(1) <u>Statement of the Work to Be Performed by ICNU for which ICNU is Seeking the Issue Fund Grant:</u>

ICNU has retained Davison Van Cleve, P.C. to represent ICNU in MSP Activities throughout the course of 2017. The IFA defines eligible MSP Activities as MSP-related activities apart from participation in any dockets or other formal proceedings before the Commission. MSP Activities include, but are not limited to, activities described in Section XIII of the 2017 PacifiCorp Inter-Jurisdictional Allocation Protocol ("2017 Protocol").

MSP Activities do not include participation in Docket No. UM 1050 related to PacifiCorp's inter-jurisdictional cost allocation. IFA, Article 1(g).

PAGE 1 – REQUEST FOR MSP FUND GRANT AND PROPOSED BUDGET OF ICNU

(2) Statement of the Breadth and Complexity of MSP Activities:

ICNU's MSP Activities include attendance at MSP Workgroup meetings,

teleconferences, and the annual Commissioner Forum, in addition to associated communications

with MSP participants, review of materials distributed by PacifiCorp or other MSP stakeholders,

and any follow-up activity. MSP Activities to date have primarily focused upon structural

separation and Company-developed alternatives to future system-wide cost allocation methods.

ICNU has and will expect to contribute to discussion during and surrounding

scheduled MSP Activities in 2017. Moreover, based on preliminary indications from the

Company and stakeholders, ICNU expects that MSP Activities will continue throughout the

entirety of 2017, and in a relatively intensive manner, given the interim nature of the 2017

Protocol and the potential need to establish a new MSP Protocol by early 2018—a timeframe

which would allow for state commission review processes and potential approvals prior to the

expiration of the 2017 Protocol. However, at the time of filing, a full schedule of dates for 2017

MSP Activities has not been determined.

(3) <u>Significance of Any Policy Issues Directly Attributable to MSP Activities:</u>

PacifiCorp's inter-jurisdictional cost allocation methodology is used to allocate

the costs of its generation, transmission, distribution and wholesale activities among its various

service territories. All of PacifiCorp's states, except Washington, currently use the

2017 Protocol to allocate the Company's costs. The MSP Activities may result in the

identification of emerging issues which affect current cost allocation methodology, or which will

be instructive toward continuing discussion of appropriate inter-jurisdictional cost allocation

when the 2017 Protocol expires on December 31, 2018.

MSP Workgroup teleconferences have been held on January 12 and February 7,

2017. In addition, the annual Commissioner Forum took place in Salt Lake City, Utah, on

January 25, 2017. Going forward, PacifiCorp has scheduled MSP Workgroup meetings on

February 22 and March 22, 2017, in Portland and Salt Lake City, respectively.

While no other firm meeting or teleconference dates have yet been established,

ICNU expects that process will be fairly intensive and continuous throughout the year. For

instance, stakeholders have discussed the potential of all-day meetings in the coming months, to

maximize efficient discussion.

(5) <u>Participation of Other Parties that Adequately Represent the Interests of</u>

Customers:

ICNU represents the interests of industrial customers that purchase electricity

directly from PacifiCorp. ICNU's participation will directly benefit industrial customers, as well

as other large non-residential customers who purchase service from PacifiCorp. No other

organization represents the interests of Oregon industrial customers in the MSP Activities.

(6) <u>Statement of Activities to Be Performed by ICNU for which ICNU is Seeking an</u>

MSP Fund Grant:

ICNU will participate in all aspects of 2017 MSP Activities to address emerging

inter-jurisdictional cost allocation issues, including attending any associated or follow-up

clarifying sessions, workshops, settlement conferences, meetings, and oral presentations. ICNU

may conduct discovery related to these MSP Activities. ICNU's attorney and/or consultant will

review, analyze and comment on issues related to emerging cost allocation matters for

PacifiCorp, including issues emerging from discovery initiated by other parties.

DAVISON VAN CLEVE, P.C. 333 SW Taylor, Suite 400 Portland, OR 97204 (7) <u>Description of Areas to Be Investigated by ICNU Relating to MSP Activities:</u>

ICNU will investigate whether Oregon will be paying its fair share of

PacifiCorp's generation, transmission, distribution and wholesale costs and revenues relative to

emerging issues discussed at MSP Workgroup meetings and teleconferences, as well as at the

Commissioner Forum. ICNU will also investigate any potential impacts to Oregon ratepayers of

Clean Air Act rules and the formation of a regional ISO, relative to how such issues develop on

state and federal political levels in 2017, in additional to any other legal mandates that may arise.

Depending on the development of ongoing MSP Activities, ICNU might investigate a wide array

of issues, including those related to cost allocation of load growth, hydro resources,

conservation, renewable portfolio standards, thermal generation, and inconsistent state policies.

(8) A Budget of MSP Activities

ICNU is seeking an MSP Issue Fund Grant in the amount of \$65,000, allocated

from the PacifiCorp MSP Fund Account. ICNU estimates that the uncommitted amount

available in the 2017 ICNU PacifiCorp MSP Fund Account is \$65,000. Attached as Exhibit A is

ICNU's proposed budget detailing the expected hours and hourly rates of ICNU's attorney and

expert.

(9) Matching Funds:

As required by Section 5.1 of the MSP IFA, ICNU represents that it will use

matching funds in the form of either in-house resources or outside funding to account for or pay

at least 20% of the Eligible Expenses for which ICNU is seeking an MSP Issue Fund Grant.

Therefore, ICNU respectfully requests that the Commission issue an order

granting an MSP Issue Fund Grant in the amount of \$65,000.
