MOTION FOR EXTENSION OF TIME TO FILE AMENDED COMPLIANCE FILING

EXPEDITED CONSIDERATION REQUESTED

- Pursuant to OAR § 860-001-0420, Northwest Natural Gas Company ("NW 1 Natural") submits this motion for an extension of time to file its amended compliance 2 filing. On January 26, 2016, the Oregon Public Utility Commission ("Commission") 3 issued Order No. 16-029 that resolved the remaining issues in this docket and directed 4 NW Natural to file an amended compliance filing within 30 days. Currently, the amended 5 compliance filing is due on February 26, 2016. NW Natural respectfully requests an 6 additional 14 days to file the amended compliance filing. NW Natural requests this 7 extension in order to allow time for the parties to this docket to review the amended 8 compliance filing and address any potential concerns in advance of the Company's filing. 9 With the 14 additional days, NW Natural will file the amended compliance filing on 10 11 March 11, 2016.
