Request for Determination of the Prudence of Environmental Remediation Costs for the Calendar Year 2013 and the First Quarter of 2014 NW NATURAL'S REQUEST TO WITHDRAW ITS APPLICATION FOR RECONSIDERATION AND/OR CLARIFICATION

(UM 1706)

On March 31, 2015, Northwest Natural Gas Company (NW Natural or the 1 Company) filed an Application for Reconsideration or, in the alternative, for Clarification of 2 Order No. 15-049, issued on February 20, 2015 (Application). Specifically NW Natural 3 asked the Commission to reconsider or clarify that portion of its Order No. 15-049 (Order) 4 in which it directed NW Natural to hold approximately \$100.3 million in insurance proceeds 5 to be applied to future remediation costs "in a secure account, with interest accruing at the 6 7 highest rate the company is able to obtain while reasonably minimizing the risk to the principal"1. The Company pointed out that it had incurred a tax liability of 39.5 percent on 8 the insurance proceeds and therefore asked the Commission to issue an order confirming 9 that only the after-tax balance need be held in a secure account.<sup>2</sup>. 10

1 On April 15, 2015, Commission Staff (Staff), Northwest Industrial Gas Users 2 (NWIGU), and Citizens' Utility Board of Oregon (CUB) all filed briefs opposing NW 3 Natural's Application, and NW Natural filed a Reply on April 22. On May 1<sup>st</sup>, 4 Administrative Law Judge Pines instructed the parties to "meet and confer regarding the 5 issues raised in the application and in the responses to the application" and to report back 6 to the Commission on any agreement they may be able to reach.<sup>3</sup>

7 Over the past two weeks the parties have met in an attempt to settle their 8 differences regarding the appropriate treatment of the insurance proceeds that will be 9 applied to future remediation expenses, and in particular, how those proceeds should be 10 held and what rate interest should accrue. The parties have now reached an agreement 11 in principle which they intend to memorialize, in a Stipulation and supporting brief, and file 12 with the Commission by June 16, 2015. At that same time, the parties would file a motion 13 requesting that the Commission amend its Order, pursuant to its authority under ORS 14 756.568, in accordance with the parties' agreement.
