HB2193 Energy Storage

Oregon House Bill 2193 directs the Public Utility Commission (OPUC or Commission) to adopt guidelines by <u>January 1, 2017</u> for an electric company to use in submitting a proposal for developing projects that includes one or more energy storage systems. In developing the guidelines, the commission shall "examine the potential value of applying energy storage system technology" within the context of six specified categories plus a seventh "other" category to be defined: 1) Deferred investment in generation, T&D 2) Reduced need for peak generation, 3) Integration of renewable resources, 4) Reduced GHG

emissions 5) Improved reliability of transmission or distribution systems 6) Reduced portfolio variable power costs, 7) Other

The commission will consider ways in which to encourage electric utilities to invest in different types of energy storage systems and any other reasonably related factors. The bill requires a report on the implementation of HB2193 to be submitted to the interim legislative committee related to energy on or before September 15, 2016.

The purpose of this first workshop is to give the opportunity for interested parties to offer input to Staff based on the following questions.

- 1. How should values and metrics, 3(1)(a)(A-F), be defined in the guidelines?
- 2. What other values and metrics should be considered, 3(1)(a)(G), in the guidelines?
- 3. What methodologies, if any, should be prescribed in the guidelines in order to quantify values A-G?
- 4. What ideas should be considered as ways to encourage investment in different types of systems, 3(1)(b)?
- 5. What other considerations should be addressed in the guidelines?
- 6. Do you have feedback on strawman schedule for Phase 1?
