SETTLEMENT STATUS REPORT

Consistent with the Administrative Law Judge's July 14, 2017 Ruling, PacifiCorp

provides the following status update on the settlement in this docket.

The Stipulating Parties (PacifiCorp, Public Utility Commission of Oregon Staff, Oregon Citizens Utility Board, Industrial Customers of Northwest Utilities, Forth, Greenlots, and the Oregon Department of Energy) have finalized the terms of a settlement stipulation. The Stipulating Parties are in the process of executing the stipulation.

The Stipulating Parties are collaborating on joint testimony to support the settlement. PacifiCorp distributed an initial draft of the joint testimony to the Stipulating Parties on July 27, 2017.
