



Program Administrator's Project Recommendation

July 12, 2022

Community Solar Program - Docket No. UM 1930

On January 11, 2022, in Order No. 22-007, the Commission permitted the delegation of Commission authority to the Community Solar Program Administrator (PA) to grant noncontroversial project precertifications, waivers, extensions, and amendments. Under the permitted delegation of authority, Staff will post the PA's project recommendation to UM 1930 with a comment period of two weeks. If no comments in opposition are received prior to the end of the comment period, the recommendation will go into effect. If comments in opposition are received prior to the end of the comment period, the recommendation will not go into effect and the matter will be referred to the Commission for a decision at the next available public meeting.

Staff posts the PA's recommendation to grant a transfer of Project Manager for the following projects:

PGE-2020-15 (Belvedere Solar) PGE-2020-19 (Dover Solar)

The PA has reviewed the project certification deadline extension requests for the two projects and has recommended granting the transfer of Project Manager. The extension requests for both projects is included at the bottom of this document. Staff finds the PA's recommendations to be noncontroversial and that granting pre-certification may be delegated to the PA. Stakeholders in opposition of the PA's recommendation should post comments to UM 1930 by July 26, 2022.

Dear Program Administrator,

We are writing on behalf of Solar Town, LLC, a registered Project Manager, Dover Solar LLC, and Belvedere Solar LLC in the Oregon Community Solar Program (the "CSP").

We have recently become aware of a requested change previously made by Matt Chou, a prior employee of SPI Solar, Inc., the owner of Solar Town LLC, Dover Solar LLC and Belvedere Solar LLC who submitted a request to the Program Administrator to transfer the Project Manager responsibilities of the Dover Solar project and Belvedere Solar project from Solar Town LLC to the respective project LLCs. This change had not been approved internally at SPI and Matt Chou is no longer an employee of the Company. Based on our understanding of the situation, there was no reason for the change to occur.

On behalf of Dover Solar LLC and Belvedere Solar LLC, and through this Letter, we hereby submit an Amendment Request that Solar Town LLC be reinstated as the Project Manager for the Dover Solar and Belvedere Solar projects. Solar Town LLC will continue to act as Project Manager as it has been. We appreciate your consideration in this matter.
