Re: Waconda Solar v. Portland General Electric Co.
Docket No. UM 1971

Dear Judge Allwein,

Waconda Solar, LLC (“Waconda Solar”) submits this letter requesting clarification on the deadline for Waconda Solar’s Response to Portland General Electric Company (“PGE’s”) Modified Second Motion for Summary Judgment (“Motion for Summary Judgment”). PGE filed its Motion for Summary Judgment on September 15, 2021.¹ Waconda Solar filed a Motion to Stay requesting the due date for Waconda Solar’s Response to PGE’s Motion for Summary Judgment be due three weeks after the Oregon Public Utility Commission (“Commission”) makes a decision on the Petition for Declaratory Ruling filed by the Renewable Energy Coalition, Community Renewable Energy Association, and Oregon Solar + Storage Industries Association in Docket No. DR 57.² In the alternative, Waconda Solar requested an extension of the deadline to file its Response until three weeks after the Commission issues a decision on whether to stay the proceeding.³ PGE has opposed the Motion to Stay but agreed to an extension of the deadline to file the Response until November 9, 2021.⁴

Waconda Solar is seeking clarification regarding the due date for its Response to PGE’s Motion for Summary Judgment. Waconda Solar is not opposed to Judge Allwein taking all the time necessary to decide on the Motion to Stay. However, Waconda Solar seeks clarification on due dates. If Judge Allwein is not inclined to grant the Motion to Stay and not inclined to grant Waconda Solar the three-week extension from the date of the decision on the Motion to Stay, then at a minimum Waconda Solar requests additional time to file its Response beyond November 9, 2021 due to other pressing business.
