9 On December 23, 2019, the Commission issued a ruling suspending these proceedings  
10 pending resolution of rulemaking proceedings in AR 631 addressing procedures, terms and  
11 conditions associated with qualifying facilities for standard contracts. On February 19, 2021, the  
12 Commission denied Portland General Electric Company (PGE)’s request to lift this matter out of  
13 suspension and directed Staff to file status reports in this docket on April 16, 2021 and August  
14 30, 2021 to apprise the Commission of the progress of AR 631.

15 In Docket No. AR 631, Staff issued a proposal for revisions to the PURPA contracting  
16 process and contract terms. Staff has had two workshops with stakeholders regarding the  
17 proposal and stakeholders have filed one round of comments. Staff is preparing a revised  
18 proposal based on the feedback of stakeholders.

19 In Docket No. AR 631, the Joint Utilities (PGE, PacifiCorp, and Idaho Power Company)  
20 have proposed to engage in a collaborative process to draft a standard contract to be used by all  
21 utilities. Staff is considering this proposal and it will be further discussed at the next workshop.

22 On March 12, 2021, Staff issued a draft schedule for the remainder of the informal phase  
23 of AR 631. At the April 7, 2021, workshop, Staff received feedback on its proposed schedule  
24 and plans to publish an adjusted schedule. The updated schedule includes:

- 25 • Staff providing an updated proposal to reflect feedback received and whether the AR 631  
26 informal rulemaking process should include development of a standard contract;

- An opportunity for participants to respond to each other's March 30, 2021 comments in writing, with the context of what's included in Staff's updated proposal,
- A final workshop before Staff circulates draft rules and, potentially, draft standard contract language.
