DRAFT GUIDELINES AND REQUEST FOR PUBLIC COMMENT

Draft Guidelines

Staff announces draft Distribution System Planning (DSP) Guidelines. Included with this announcement are 1) an Introduction and 2) Appendix 1, which contains the draft Guidelines. The Introduction provides context for the Guidelines. Staff anticipates the Introduction will serve as the draft basis of a Staff Memo articulating Staff's recommendation for Commission adoption of Guidelines, at a Public Meeting later this year. Appendix 1 outlines requirements for the initial utility DSP Plans that may be submitted to the Commission in 2021.
