Background Information on DSP

PGE, Pacific Power, and Idaho Power filed Part 1 of their inaugural Distribution System Plans on October 15, 2021. Part 1 filings were required by <u>Order No. 20-485</u>, which established DSP Guidelines.

Part 1 filings were included in Docket No. UM 2005, however separate dockets were established for each utility Plan. Review, public comment, and Commission action will be conducted in these dockets:

Idaho Power – Docket No. UM 2196, PGE – Docket No. UM 2197, Pacific Power – Docket No. UM 2198
