Energy Justice Issues Public Workshop

Summary

The goal of this workshop is to continue discussions started during the March 5th Commissioner workshop to improve procedural equity in Idaho Power Company's 2024 General Rate Case (Docket No. UE 426) by giving environmental justice (EJ) communities additional opportunity to dialogue on high priority issues impacting EJ communities.

Following the March 5th workshop, Staff has made adjustments to this workshop to ensure that dialogue and engagement occurs between EJ communities, the Company, and other participating stakeholders. The information shared in this public workshop will help inform settlement discussions and ensure that EJ perspectives are not left behind in comprehensive settlement agreements and that historically underrepresented voices have an opportunity to contribute in a space that includes barriers to participation.

Staff looks to provide an overview of opening testimony positions identified by Staff and intervenors, as well as frame the following topics from a customer experience perspective that will allow public participants and advocates to weigh in on potential solutions. While we have identified a number of topics from opening testimony and the March 5th Commissioner workshop, we welcome discussion on other issues related to EJ communities including, but not limited to:

- Bill Discount and recovery
- Arrearage management
- Overall bill impacts
- ROE
- RS/RD
- Basic charge
- Weatherization and Energy Efficiency
