# Scoring of RFP Bidders (1 of 2)

### Ability to Perform (400 Points)

Demonstrated training, experience and ability of the bidder and its individual staff member(s) that will be assigned to the project to perform the proposed services, including:

- 50 points Understanding the scope of services and deliverables.
- 75 points Specific experience reviewing an RFP for transmission, renewable, and non-renewable market purchase resources, including experience with evaluating benchmark and market bids.
- 75 points Experience evaluating new or existing resources, including storage options such as BESS
- 50 points Experience evaluating another type of renewable resource RFP, or other related experience in the WECC
- 75 points Experience with utility applications of production cost modeling specific to firm transmission, and renewable and non-renewable generation resources as part of an RFP
- 75 points Initial assessment and review of the scoring methods and computer models as described in Attachment D – IPC's Proposed 2026 RFP Bid Evaluation and Selection Process

# Scoring of RFP Bidders (2 of 2)

### Price Proposal (300 Points)

Attachment E – Respondent Pricing Proposal will be the basis for evaluation of Respondent's proposal of the overall cost of the project, the overall elements of that cost, and the overall appropriateness of the submitted costs in relation to the submitted proposal.

- 150 points Total price of the proposal, and the overall elements of that price.
- 150 points Overall appropriateness of the cost in relation to the submitted proposal.

### **Acceptance of Contract Documents (50 Points)**

 Respondents must provide redlines and comments to Attachment A – Professional Services Agreement

## **Bid Evaluation**

#### **Initial Review**

Idaho Power and OPUC Staff review all submitted proposals to help ensure that all prescribed provisions and procedures have been met.

- Proposals that do not meet all prescribed mandatory minimum qualifications, solicitation procedures and requirements, may be rejected or further eliminated from the selection process.
- Submitted proposals meeting the prescribed solicitation requirements will be reviewed by IPC, Oregon Commission Staff, and interested non-bidding parties.

### **Evaluation**

Idaho Power and OPUC Staff will meet to discuss their finding and identify the leading Respondents for final recommendation to the OPUC.

### Scoring

Respondents with the highest scoring proposals will be recommended to the OPUC for consideration.

#### Recommendation

OPUC Staff will issue a report for the OPUC public meeting five (5) days prior to the public meeting with its recommendation for an IE.

### **OPUC's Decision**

The OPUC will consider Staff's recommendation and comments from Idaho Power and non-bidding parties in selecting the IE, but the ultimate discretion to select an IE lies with the OPUC. The OPUC will direct Idaho Power to enter into a contract with the selected IE at a Public Meeting on a date to be determined.
