On May 3, 2011, Portland General Electric Company ("PGE") submitted an application requesting that the Commission require it to sign the Revised REP Settlement Agreement as defined therein (the "Application"). On March 22, 2011, PGE filed a request (the "Initial Request") asking the Commission to require it to sign the Residential Exchange Program Settlement Agreement ("Original REP Settlement Agreement") and the proposed form of Residential Exchange Program Settlement Implementation Agreement between Bonneville Power Administration ("BPA") and PGE ("REP Settlement Implementation Agreement") if BPA offers this implementing agreement to PGE. On April 11, 2011, the Commission issued Order No. 11-114, ordering PGE to sign the Original REP Settlement Agreement and if offered by BPA, the REP Settlement Implementation Agreement. A copy of the form of the REP Settlement Implementation Agreement is attached as Exhibit 2 to the Initial Request, and its terms are summarized in the Initial Request.
