ANNOUNCEMENT OF PROPOSED CHANGES TO WATER SERVICE RATE TARIFFS FILED WITH THE PUC

Date: **August 25, 2021**

Sunriver Water LLC submitted a general rate filing to the Commission on May 28, 2021. We are seeking to increase our annual revenues by \$726,542 above the \$1,843,448 we collected in 2020. The Commission has created docket UW 186 for this filing and suspended the effective date of new rates pending its investigation. The Commission will schedule additional procedures for this filing, including public comment hearings. The purpose of this announcement is to provide you with general information regarding the proposed rates and the effect the filing may have on you. If approved, we anticipate the increase will change average monthly water service bills as follows:
