1 I, Tim Smith, hereby declare that the statements below are true to the best of my knowledge
2 and belief and that I understand these statements are admissible as evidence in legal
3 proceedings and subject to penalty for perjury.

4 1. My name is Tim Smith. I am employed by Sunriver Water LLC (“Sunriver Water” or
5 the “Company”) as its General Manager.

6 2. Public Utility Commission of Oregon (the “Commission”) Order Nos. 22-085 and 22-
7 088, entered March 21 and 23, 2022, respectively, adopted the uncontested
8 Stipulation between the parties, Sunriver Water, Staff of the Public Utility
9 Commission of Oregon and Sunriver Owners Association, filed on January 28, 2022
10 (the “Stipulation”). Paragraph II.3.a of the Stipulation states, in relevant part: “The
11 Company also agrees to file an attestation of a Company officer attesting to the date
12 upon which the above-referenced 2021 rate base additions have been placed in
13 service and their cost.”
