## Re: Docket WJ 9: Rice Hill Water District

Dear ALJ Petrillo:

On June 7, 2007, Jason Jones updated you on the general timeline agreed to by the parties at an informal meeting on June 5, 2007. This letter notifies you of a change in this timeline.

Since the informal meeting of the parties on June 5, 2007, The Rice Hill Owners Association, Inc. ("RHOA") became aware of issues that cause it to believe the parties need additional time to develop a statement of facts. The parties originally agreed to circulate a statement of facts by July 3, 2007. I discussed these new issues with Michael Dougherty and Michael Weirich on June 25, 2007. They stated that PUC staff would not oppose an extension of the timeline. On June 26, 2007, I also spoke with the President of the Rice Hill West Homeowners Association Romeni Bechtold, a member of the Association who originally petitioned the PUC in this docket, and she also had no objection to the extension. Mr. Webb's attorneys did not respond to my e-mail and telephone call regarding an extension.

RHOA proposes that the parties meet or participate in a telephone conference the week of July 3, 2007, or July 9, 2007, to discuss the new issues affecting the docket and to decide on a timeline going forward. The parties will provide you with another update in the middle of July.
