This letter provides you with an update on the status of informal discussions among the parties in this docket.

On September 26, 2007, The Rice Hill Owners Association, Inc. ("RHOA") met with the other parties to this docket, Oregon Public Utility Commission ("PUC") staff, and the Rice Hill West Homeowners Association ("Association") to attempt to resolve the petition pending before the PUC in this docket. The parties, PUC staff, and the Association agreed that the negotiation of a wholesale water supply agreement between RHOA and the Association may be in the best interests of the parties and could resolve the pending petition. To that end, RHOA and the Association will attempt to negotiate a wholesale water supply agreement pursuant to which RHOA would supply the Association with water. PUC staff has offered to assist in the negotiations as needed. If RHOA and the Association are unable to reach an agreement, the parties will continue with formal proceedings before the PUC to resolve the petition.

RHOA and the Association estimate that by November 30, 2007, they will either have substantially finalized an agreement or will have concluded they are unable to reach an agreement. Therefore, RHOA will provide the PUC with an update on the status of negotiations between RHOA and the Association on or before December 7, 2007.
