QWEST CORPORATION'S AND COVAD COMMUNICATION COMPANY'S JOINT MOTION FOR ADDITIONAL TIME TO FILE INTERCONNECTION AGREEMENT

Qwest Corporation ("Qwest") and Covad Communications Company ("Covad") submit this joint motion for additional time to file the interconnection agreement ("ICA") required under the Commission's Arbitration Order issued September 6, 2005 (Order No. 05-980). The Order requires the parties to submit the ICA by October 6, 2005. Through this motion, the parties are seeking an additional two weeks for the submission.

The parties have prepared a draft ICA that incorporates the rulings in Order No. 05-980 and have been engaged in regular discussions toward finalizing the draft. Through this process, the parties have reached agreement upon the language for all but a small number of the sections in the ICA. With respect to the provisions that are still under discussion, the parties expect that further discussion will result in agreement. However, the fairly complex nature of the provisions still under discussion, coupled with a scheduling conflict for the Qwest employee responsible for preparing the final version of the agreement, will prevent the parties from completing their discussions and submitting a final, signed agreement by October 6th. The parties believe that with an additional two weeks, they will be able to submit a final agreement and agree that neither party will be prejudiced by this extension.

Accordingly, Qwest and Covad respectfully request that the Commission issue an order extending the time for filing the final ICA from October 6, 2005 to October 20, 2005.
