Dear Judge Petrillo:

On March 14, 2007, the Commission issued Order No. 07-098 adopting the Arbitrator's Decision with modifications in this interconnection arbitration docket.

One of the requirements in that order is for the parties to file an interconnection agreement that is consistent or compliant with the order within 30 days, or by April 13, 2007 (today). The parties have been working diligently to try to agree on a compliant agreement, but there are still two issues to which they have not yet agreed. Nevertheless, they continue to make progress and are hopeful that they can negotiate and resolve any disputes on these issues very shortly.

Accordingly, both Qwest and Level 3 kindly request a one-week extension, until April 20, 2007, in which to file an interconnection agreement consistent with Order No. 07-098.
