Re: ARB 775 (Eschelon/Qwest)- Joint request for modest schedule changes

Dear Judge Arlow:

An issue has arisen since the prehearing conference on April 23, 2007 that requires Eschelon and Qwest to request some modest adjustments to the procedural schedule that you set during the conference. Specifically, the parties will now be addressing in the arbitration some issues that they have not addressed in prior arbitrations in other states. As a result, Qwest sought Eschelon's agreement on a small amount of additional time to prepare testimony, and Eschelon has concurred.

Accordingly, the parties ask that you consider the following scheduling changes:

- (1) Direct Testimony: May 11 instead of May 3;
- (2) Rebuttal Testimony: May 25 instead of May 24;
- (3) Surrebuttal Testimony: June 8 instead of June 5; and
- (4) Hearing: June 18-20 instead of June 12-14
