We represent Eschelon Telecom of Oregon, Inc. ("Eschelon"). On October 10, 2006, Eschelon filed a Petition for Arbitration with Qwest Corporation Pursuant to 47 U.S.C. Section 252 of the Federal Telecommunications Act of 1996 ("Petition"). Included with the Petition was a proposed schedule for the proceedings.
