Re: Request to Surrender the Certificate of 360networks (USA) inc.

Dear Sir or Madam:

On behalf of Zayo Group, LLC ("Zayo"), the successor to 360networks (USA) inc. ("360networks" and together with Zayo, the "Company"), this letter hereby voluntarily surrenders 360networks' certificate of authority as a competitive telecommunications provider of intraexchange service and interexchange (private line (point-to-point) and switched (toll)) services granted by Order No. 07-174 in Docket No. CP 1363 (the "Certificate").

As described more fully in the letter filed by the Company on December 21, 2012, 360networks merged with and into Zayo, with Zayo surviving the merger. The merger was completed on March 12, 2013 and, as a result, 360networks no longer exists as separate corporate entity and Zayo provides telecommunications to 360networks's customers pursuant to Zayo's certificate of authority granted by Order No. 11-147 issued in Docket No. CP 1177. Since 360networks no longer exists and Zayo provides services to 360networks's customers, 360networks's Certificate should be cancelled effective March 12, 2013 or as soon as the Commission can take any appropriate administrative action.
