

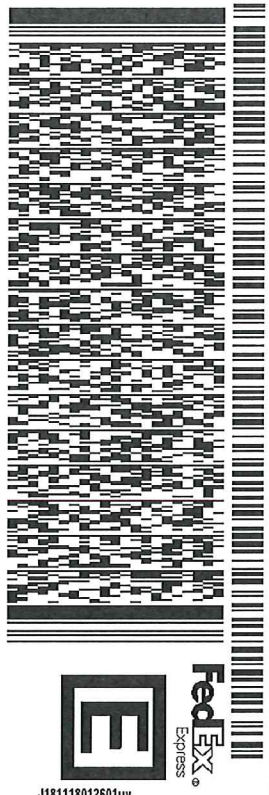

**RE: CP 1421, Request to Cancel Certificate of Authority, iBasis Retail Inc.**

Dear Ms. Cookingham:

On behalf of iBasis Retail (the “Company”), we hereby request that its Certificate of Authority (Docket No. CP 1421) be cancelled. The certification, which relates to the Company’s prepaid calling card business, is no longer necessary because the Company has ceased selling its prepaid calling cards to distributors in all states including Oregon. In Oregon there have been no distributor sales for more than two years. Moreover, in 2016 and 2017 the intrastate revenue in the state has been \$38.19 and \$5.79 respectively. While the Company has ceased all its sales to distributors, it will continue to maintain its 1-800 customer service number for at least three years in order to ensure that consumers who still have any prepaid cards are properly taken care of and made whole if they have any problems.

After discussions with Kathy Shepard the Company is aware of its final compliance obligations once the Certificate of Authority is cancelled, including the year to date Statement of Gross Operating Revenue including its associated payment of \$100.00 and any final quarterly OR USF filings that may be required.
