Pursuant to OAR 860-013-0031, staff of the Public Utility Commission of Oregon (“staff”) moves the administrative law judge to modify the procedural schedule in the above-captioned dockets to allow an additional two days, until Friday, July 20, 2007, for the parties to prepare and file their reply briefs. Counsel for staff has contacted all of the parties that filed opening briefs in these matters, and none of them object to this request.
