MOTION FOR GENERAL PROTECTIVE ORDER

Expedited Consideration Requested

Under ORCP 36(C)(7) and OAR 860-001-0080(1), PacifiCorp d/b/a Pacific Power (PacifiCorp or Company) moves the Public Utility Commission of Oregon (Commission) for entry of a general protective order in this proceeding. The Company will file its 2017 Integrated Resource Plan (IRP) on or about March 31, 2017. The Company requests expedited consideration of this motion to facilitate IRP workshops scheduled for December 15 and 16, 2016, where confidential information will be provided to stakeholders. Good cause exists to issue a Protective Order to protect commercially sensitive and confidential business information related to the Company's long-term resource planning.

The Commission's rules authorize PacifiCorp to seek reasonable restrictions on discovery of trade secrets and other confidential business information.¹ The Commission's general protective order is designed to allow the broadest possible discovery consistent with the need to protect confidential information.² PacifiCorp will be holding stakeholder workshops where

proprietary cost data and models, commercially sensitive pricing information, and confidential market analyses and business projections will be discussed. PacifiCorp will be exposed to competitive injury if it is forced to make unrestricted disclosure of its confidential business information.

It is also substantially likely that parties to this proceeding will seek to discover further information held by PacifiCorp after the 2017 IRP is filed on or about March 31, 2017, including confidential and proprietary business information. Issuance of a protective order will facilitate the production of relevant information and expedite the discovery process.

For these reasons, PacifiCorp respectfully requests that the Commission enter its general protective order in this docket. The Company requests expedited consideration of this motion to allow stakeholders who execute the protective order to participate in confidential workshops scheduled for December 15 and 16, 2016.
